**STANDARDS AND REGULATIONS \*\*IMPORTANT\*\***

**READ BEFORE SIGNING APPLICATION**

- ❖ Once your space rental is confirmed, you are committed to be open during all scheduled hours, both days. No refunds will be made within 20 days of the show.
- ❖ Due to limited electricity service on the Festival Grounds, ANYONE in need of electricity should be prepared to provide for themselves or pay an additional \$25.00. Each booth must be self contained and independently operated. All food vendors must be licensed and be in compliance with health department guidelines and have appropriate certificates on display. Vendors are required to dispose of their own waste products (cooking oil, garbage, trash, etc.) Trash receptacles will be provided for customers.
- ❖ Each vendor must supply their own display, tables and chairs for their space, and is responsible for complete cleanup of their area. Please be prepared for inclement weather, as there are no rain dates. Set up and break down times will be enforced. No vehicles are allowed in the show area before closing time. NO vehicle parking will be available at booth locations. All sites will have access for loading and unloading.
- ❖ Smoky Events does not provide or guarantee security for booths or contents. Neither Smoky Events nor the Town of Maggie Valley will be held responsible for any damage to the property or persons participating in the show.
